| Statistics

- **Bureau of Labor Statistics**

The Bureau of Labor Statistics of the U.S. Department of Labor is the principal Federal agency responsible for measuring labor market activity, working conditions, and price changes in the economy. Its mission

is to collect, analyze, and disseminate essential economic information to support public and private decision-making.

- **Federal Interagency Forum on Aging-Related Statistics**

This is the site of the Federal Interagency Forum on Aging-Related Statistics from which you can obtain their report: Older Americans 2004: Key Indicators of Well-Being. This report covers 37 key indicators of aspects of the lives of older Americans and their families. The report is divided into five subject areas: population, economics, health status, health risks and behaviors, and health care.

- **Health and Retirement Study**

Supported by the National Institute on Aging, The University of Michigan Health and Retirement Study (HRS) surveys more than 22,000 Americans over the age of 50 every two years. The study paints an emerging portrait of an aging America's physical and mental health, insurance coverage, financial status, family support systems, labor market status, and retirement planning.
